C4DP TRAININGS: What's Available and the Potential Impact

Learning Systems Manager, Jackie Palacios led a presentation on the community impact of our C4DP Saving Lives Protocol Training Sequence. She presented data from FY 21-22. Some key takeaways; agencies feel more confident connecting their clients to C4DP, parents feel more comfortable talking with their children about unhealthy relationships, and staff/community members feel more knowledgeable about the warning signs of an abusive partner.

In FY 21-22 229 people were trained across 10 community organizations. In FY 22-23 208 people were trained across 8 community organizations. The trainings offered vary and can be adjusted to fit the needs of your agency.

These trainings include:

1. **DV101:** This 1-hour course is an overview: we address the different types of abuse, the pattern of abuse, warning signs, data and statistics, as well as what to do if you or someone you know may be in an abusive relationship. Open for your agency's employees, board members, interns, etc. Designed to build your whole agency's common understanding of the dynamics and definitions of dating and domestic violence.
2. **Become a C4DP Connector (Services Training):** This 1-hour training describes the services offered at Center for Domestic Peace, who is eligible for those services, and **how to access them**. This includes information on our Emergency Shelter, Economic Empowerment Program, Therapy Programs, Youth Programs, and more! Designed to increase your understanding about what we offer and what your clients can expect if they reach out to us.
3. **Domestic Violence Risk Level assessor:** This 2-hour training is for those who would like to learn how to use a trauma informed and survivor centered approach to help survivors determine their level of risk. Learn the 5 DV Risk Level Assessor Steps through an interactive training which includes a guide. Designed to identify and train 1-3 Assessors who can be the point persons for survivors your agency is assisting.
4. **NEW: "Should I Talk With My Kids About What They Saw Or Heard?" Parent Training:** 1.5 hour training for parents to learn the effects of adult's unhealthy relating and how to talk to their children. Designed to break the intergenerational passage of dating and domestic violence so we end these crimes now and forever.

Kate Kain introduced C4DP Prevention Manager, Jonathan Deras. Jonathan has more than 5 years of experience working in domestic violence prevention, intervention, and campaigns with youth and young adults. Deras spearheaded the development of a healthy masculinity curriculum and program – Champion Men’s Zone.

Jonathan presented part of the curriculum taught in his prevention programs and then introduced our two panelists, Alejandro Reyes and Alex Hernandez. These two young men have been involved with C4DP’s prevention programs.

During the panel, Alejandro and Alex shared what they have learned from Jonathan and his curriculum including; healthy masculinity, warning signs of unhealthy relationships, hook-up culture and much more. They also shared what this program has meant to them personally and how they are hopeful that this crime can end in their lifetimes.
