### **Special Training for CCR Members: “How to Help Dating and Domestic Violence Survivors Be Safer In the Digital Age” 90-Minute Hands-on training with Tech Abuse Expert Adam Dodge, Founder, End Tech-Enabled Abuse**

Kate Kain introduced Adam Dodge and recognized him for his various accomplishments from his work on the White House Task force to address online harassment and abuse, to his multiple publications and interviews with Vogue Magazine, VICE, and the Washington Post. Adam, a leading expert in this emerging field of combating tech enabled abuse provided a 90-Minute training.
