Introductions and Disclosures:

Kate Kain (C4DP Deputy Executive Director) reviewed the agenda and our CCR Disclosures. DED Kate Kain also invited CCR network to order and stock up on hard copy pamphlets, fliers, and posters by ordering more materials from the C4DP website.

Gap Analysis/Sub Committee Report- Luz Alvarado, Legal Systems Advocacy Program Director

C4DP provided a gap analysis based on points brought up at our last CCR meeting and our April subcommittee meetings. This gap analysis described the problems mentioned by all different pillars of the CCR (Policy and Procedure, Data and Evaluation, CCR Expansion, and Prevention, Outreach, and Education) as well as solutions discussed by our CCR partners.

Luz Alvarado (Legal Systems Advocacy Program Director) reviewed what was discussed in our previous "Super Thursday" subcommittee meetings.

Topics covered included:

1. Policy and Response Subcommittee Gap Discussed: Marin County victims being treated differently based on skin color.
2. CCR Expansion Subcommittee Gap Discussed: A lack of representation from groups that work with youth and families.
3. Data and Evaluation Subcommittee Gap Discussed: Data needed from YOUTH about their understanding of healthy vs unhealthy relationships. Is it evolving or changing?
4. Preventing Future Abuse Subcommittee Gap Discussed: Need more engagement with youth.

Guest Panel Presentation: Hot Off the Press: Crime Rate Going Down in Marin County.. But Why?- Hint... it fits in your pocket!

Kate Kain provided a summary of the processes and information contained in the Marin County Law Enforcement Response to Domestic Violence Pocket Card.

Bill Granados provided his findings from the Marin County Law Enforcement Data Project which took place during the years 2013-2019. The baseline data collected was Domestic Violence related calls for service to Marin County police. Bill Granados presented evidence that shows a correlation between the Law Enforcement use of the Marin County Law Enforcement pocket card which provides instructions for officers when responding to the crime scene, and a drop in the DV service calls that can only be seen in Marin County during those years.

Donna Garske provided a summary history of the development of the role of the Marin County Law Enforcement Domestic Violence Liaison and the Marin County Law Enforcement Response to Domestic Violence pocket card: how it was developed, obstacles faced, and implementation.

Luz Alvarado acknowledged and thanked the Law Enforcement Domestic Violence Liaisons for their instrumental role in this crime reduction.

Speaking of Pocket Cards...Now There's One For All Providers

Kate Kain invited CCR members to attend C4DP's Domestic Violence Risk Level Assessor Training which provides a guide and training for providers on how to help their participants evaluate the lethality level of domestic violence in 5 steps. Similar to the pocket card used by Marin County Law Enforcement, this training includes learning and practicing domestic

violence risk assessment, using an Assessor guide, connecting victims to C4DP and learning about C4DP services. If interested, contact jpalacios@c4dp.org
